


# **New Mexico Prescribed Fire Council Minutes**

#### 1. Council Business

a. Approved agenda for current meeting and minutes from previous meeting.

Field trip will be on the Rancho Lobo, north of Chama. Lots of discussion about appropriate pile burning techniques as well as acequia burning, these will be additional topics.
- b. Partnership for Firefighter Qualification Program Krys Nystrom contacted Don to discuss partnership with TNC and the National Wildfire Suppression Association to support a way to train, track and qualify nonagency personnel, Will ask either Krys or Jeremy Bailey to be ready to talk about this at the next meeting.
- c. NMSU Rx Training Workshop Doug Cram mentioned that he has been thinking about an idea where we (Rx Council) and NMSU would partner to hold a hands-on Rx Training Workshop on the university's Corona Range and Livestock Research Center; All thought it was a good idea; Would be a logical next step in our program of work, would support the function of the Rx Trailer, Doug will research what Oklahoma State University does as well as Texas A&M, and be ready to report back at the next meeting. Motion and second was secured to follow this up as a new action item.
